“Inactivated Environmental Isolate”
- Do not use for description of goods:
 - Pharmaceuticals, Bacteria, Genetic Material, Baby Formula, DNA, Medical, Microbiological, etc., or sample(s) will be delayed!
- Refer to the Charles River website for preparation of DNA extracts, liquid and dried ethanol preparations and alkaline lysis extractions.
